**Registration at the door will be \$55.00** for Delegates and Alternates with **no** meal. The charge for guests is \$15, and must be a guest of a Delegate, Alternate or BPOU officer. Delegates and Alternates may not register as guests.

1. Election of Delegates and Alternates to the Congressional and State Conventions
2. Endorsements of candidates as may be determined by the will of the Convention
3. Discussion of Resolutions and Action Items from Caucuses
4. Amendments to the BPOU Constitution, if any
5. Approval of Bylaws amendments, if necessary
6. Transaction of other business as may properly come before the convention
